

### *What is CEASecure™?*

Your program advisors at CEA Study Abroad recommend that you make our **CEASecure™** plan a key part of your study abroad program planning. Under this special refund plan, you may withdraw from your CEA program for any covered reason up to one calendar week before your program's start date. **CEASecure™** provides refunds for these covered reasons:

- **Medical** – If a student or an immediate family member of the student becomes seriously ill, is seriously injured in an accident or dies.
- **Terrorist Attack** – If the U.S. Department of State determines that there has been a terrorist attack against U.S. interests within the host country of a student's program site, and issues an official Travel Warning that Americans should not travel to that country.
- **Job Loss** – If a parent or legal guardian of a student is laid off from work or loses his/her job as a result of a general staff reduction or position elimination.
- **Total Destruction of a Student's Primary Residence** – If the student's primary place of residence is destroyed by a natural disaster, fire or explosion.

### *What is refundable prior to departure?*

A refund includes all program fees that you have paid to CEA, less the \$95 application fee, non-refundable program confirmation fee, any late fee and the cost of the **CEASecure™** plan.

### *Am I eligible for any kind of refund after my program starts?*

Yes, **CEASecure™** covers trip interruption refunds after your program has started under the following conditions:

- **Medical** – If a student or an immediate family member of the student becomes seriously ill, is seriously injured in an accident or dies.
- **Terrorist Attack** – If the U.S. Department of State states that there has been a terrorist attack against U.S. interests within the host country of a student's program site, and issues an official Travel Warning that Americans should not travel to that city.
- **Failure to Obtain a Student Visa** – If your official student visa was not issued when all documented embassy procedures were properly followed according to consulate requirements, and you have traveled to the country of your CEA program site on a tourist visa with plans to obtain the required visa, you are denied the visa and must leave the country before completing your program.

### ***How are trip Interruption Refunds determined?***

Refunds are prorated based on how far along you are in your program when a covered condition happens. As with a pre-program start refund, your \$95 application fee, non-refundable confirmation fee, any late fee and the cost of **CEASecure™** are not refundable. The aggregate amount of refunds for one incident cannot exceed a maximum amount of \$1 million.

### ***How much will CEASecure™ cost me?***

**The cost of the CEASecure™ plan is based on the type of program that you have selected.**

**Our pricing is as follows:**

- A fee of \$475 for semester and trimester programs
- A fee of \$275 for summer and short term programs
- A fee of \$1,000 for academic year programs

### ***How do I enroll in CEASecure™?***

**Yes, CEASecure™ covers trip interruption refunds after your program has started under the following conditions:**

### ***What if I choose not to purchase CEASecure™?***

**You may choose not to purchase CEASecure™.**

If you decide not to purchase the plan, you are still eligible under the CEA Standard Refund Policy, which provides a refund, depending on how close your withdrawal date is to the start of your program. Under the Standard Refund Policy, no refunds are granted after your program withdrawal date and no refunds are possible after the start of your program.
